Special General Meeting vote

If no new Committee comes forward, we will hold a vote to decide whether

- the Group closes entirely.
- the Group become a community group.

To run as a community group:

- anyone who is a member of Coeliac UK and willing to run an event needs to register with Coeliac UK to hold events, so that they benefit from the public liability insurance provided by Coeliac UK as well as from publicity and up to date information from Coeliac UK.
- information about these events can be made available by Coeliac UK through the website and via Crossed Grain.
- all members who are not on the internet and do not have emails would need to register with Coeliac UK for hard copies of the Crossed Grain magazine to be sent to them in order to find out about events.
- any money left in our account will be held by Coeliac UK and ringfenced for the community group, but only for 2 years. After that it is assumed that events will be self-supporting, and any funds held would go to Coeliac UK research funds.

2022 AGM MINUTES

<u>Minutes of West Sussex Coeliac AGM – Redeemer Centre, Worthing Guildbourne Centre</u> Saturday 25th June 2022 @ 14.30

In attendance were 17 Members and 2 non-members, including the current Committee of:
Mike Butler – Group Organiser
Gillian Carr – Treasurer
Tracey Martin – Secretary
Lisa Warring - Admin assistant

- 1. Welcome Mike welcomed all and thanked everyone for coming.
- **2.** Apologies for absence none received.
- **3. 2020 & 2021 Review** Last AGM minutes (March 2020) proposed by Nicholas seconded by Andy. There was no 2021 AGM due to COVID. Gillian summarised by saying that the committee had met via zoom during the last 2 years. Other than that, nothing formal within the group had happened during and since lockdown. However, the Worthing group have resumed meeting with coffee mornings and a Christmas meal and anyone wishing to organise any event are welcome to do so (see 6 iii)
- **4. Group Finances Report** Gillian presented accounts (see copy below) for the 2 years since the last AGM was held and reported that the group has a positive account balance of c. £7,500. This is made up of the £5K donation from Anna (received into the Group Account after the 2020 AGM) plus a residual amount of c.£2.5K in situ before Anna's legacy.
- **5. Election of Committee Members** All of the current committee indicated that they were willing to stand for re-election. In the absence of any additional volunteers, Mike, Gillian, Lisa & Tracey were re-elected enbloc. Proposer Helen, Seconder Pam. **N.B.** It was stated that there were vacancies on the committee (in particular for an Events organiser) should anyone wish to volunteer their services either today or by contacting a member of the committee at a future date.

6. Questions /Open discussion

- i) It was stated that the existing Committee members will continue to stay in place until such time as Anna's legacy had been spent in line with her wishes:- Namely £4k on an event for children in the area and a further £1K for a 'party'. (The latter not specifically being for children.). The committee are looking at a further Butlin's day and will meet in due course to discuss how to spend any remainder.
- **ii)** Gillian mentioned since lockdown some local county groups had ceased meeting and once Anna's wishes had been met it is likely that our group may also cease in a formal sense (in the absence of any volunteers coming on-board). In such an event all remaining funds will automatically transfer to Coeliac UK and with this in mind it is our preference to utilise the funds for the benefit of our local group if at all possible.
- iii) Coeliac UK have adopted a more relaxed stance on informal events being staged by individuals and are now happy for these to be advertised via the Coeliac UK website. In which case anyone wishing to publish details are welcome to contact Tracey or Lisa. Please note that these events should aim to be self-funding, however the Committee would be more than happy to be contacted about ideas for events anyone would like to organise, for which they would like some additional funding from the Group to be considered. - iv) Gillian will see if a meal might be arranged in the Mid-Sussex area.
- v) Tracey will enquire if the Worthing coffee mornings can be publicised.
- **vi)** Mike will arrange a date for a resumption of the Hassocks South Downs Garden Centre breakfast informal gatherings and notify previous attendees of the initial date along with it being added to our website.
